He has authored/co-authored numerous legal texts since he graduated in law at the age of 19, including 5 books and more than 30 articles in maritime law, arbitration, etc. His works have been widely published in the UK, Malaysia, Singapore, India, Indonesia, etc.

His next major book pending publication is *The Law of Carriage of Goods by Sea* to be published by Springer Singapore in 2021.

He has appeared at all levels of courts - Federal Court, Court of Appeal and High Court - in Malaya, Sabah and Labuan. His works have been referred to in other USA and local books and appellate court judgments. His cases widely appear in law journals, numbering about 30.
